




Osceola County Road Widening Program




Simpson Road

- Roadway widening and intersection upgrades with sidewalks, bicycle accommodations, curb and gutter, and drainage improvements
- Phase 1 Myers Road to Boggy Creek
 Construction FDOT FY 2022
- Phases 2, 3, and 4 Myers Road to US 192
 - Finalizing PD&E
 - Design advertised in Nov. 2019
 - ROW acquisition early 2020
 - Construction anticipated FY 2023

Boggy Creek Road


- Widening from 2 to 4 lanes, approximately 5.9 miles, from Simpson Road to Narcoossee Road
- Sidewalks, bicycle accommodations, curb and gutter, and drainage improvements
- Technical analysis/design advertisement in January 2020
- ROW acquisition anticipated in FY 2021
- Construction anticipated in FY 2024





Bill Beck Boulevard

- New 2-lane roadway, approximately 0.7 miles, from Osceola Parkway to Woodcrest Boulevard
- Roadway required as part of agreement with city of Kissimmee
- Sidewalks, bicycle accommodations, curb and gutter, and drainage improvements
- Design update complete in FY 2020
- Construction anticipated in FY 2021





Partin Settlement Road


- Widening from 2 to 4 lanes, approximately 2.7 miles, from Neptune Road to E. Lakeshore Boulevard
- Sidewalks, bicycle accommodations, curb and gutter, and drainage improvements
- Technical analysis/design advertisement in January 2020
- ROW Acquisition anticipated in FY 2021
- Construction anticipated in FY 2024





Poinciana Boulevard


- Widening from 2 to 4 lanes, approximately 5.8 miles, from Pleasant Hill Road to Crescent Lakes Way
- Sidewalks, bicycle accommodations, curb and gutter, and drainage improvements
- Technical analysis/design advertisement in January 2020
- ROW acquisition anticipated in FY 2021
- Construction anticipated in FY 2024





Neptune Road


- Widening from 2 to 4 lanes, for approximately 3.5 miles, from Partin Settlement Road to US 192
- Finalizing PD&E study for the widening, rehabilitation and reconstruction of Neptune Road including sidewalks, bicycle accommodations, curb and gutter, and drainage improvements
- Design advertised in November 2019
- ROW acquisition begins early 2020
- Construction anticipated FY 2022

CR 532 Widening


- Widening from 2 to 4 lanes, approximately 2.9 miles, from Old Lake Wilson Road to US 17/92
- Sidewalks, bicycle accommodations, curb and gutter, and drainage improvements
- Part of Poinciana Parkway Extension
 Project Partnership with CFX
- Technical Analysis/Design advertisement January 2020
- Construction FY 2023 FY 2024





I-4/CR 532 Interchange

- Design of modified interchange as a diverging diamond configuration
- Partnership with FDOT
- Design complete in FY 2020
- Construction in FY 2021
- State funded







Hoagland Boulevard

- From John Young Parkway to 5th Street
 - \circ 3.15 miles
 - o approximately \$39 million
 - New 2.15 mile four-lane divided roadway
 - Widening from 2 to 4 lanes about 0.91 miles of divided roadway
 - o 6' bike lanes
 - o 6'-8' sidewalks on both sides of road
 - Curb and gutter
 - Bridge over SunRail tracks and reconstruction of Shingle Creek Bridge
 - o Completion anticipated 2021

John Young Parkway/Pleasant Hill Road Intersection



- Interim Improvement to intersection
- Quad Road concept disperses traffic over two intersections
- Re-aligns entrance into The Oaks subdivision
- FDOT finalizing PD&E
- Moving into design and ROW acquisition
- Construction money being placed into FDOT work program for FY 2024



Central Florida Expressway Authority



Osceola Parkway Extension



- Preferred alignment approved by CFX Board Dec. 12, 2019
- Design in 2020
- Extend roadway to Nova Road



Southport Connector Expressway



- CFX Board approved moving forward with PD&E for Southport Connector Expressway
- PD&E has been advertised



Poinciana Parkway Extension

- Widen existing Poinciana Parkway from 2 to 4 lanes
- Poinciana Parkway Extension from US 17/92 to CR 532
- Design contract advertised in January 2020





Western Beltway Widening

- Widen the Western Beltway (SR 429) to eight lanes, from I-4 to Seidel Road
- PD&E Study planned to advertise February 2020.
- Studies will includes interchange modifications and potential new interchange access along the Western Beltway





Florida Turnpike Widening


- Widen the Turnpike (SR 91), from four lanes to eight lanes, from US 192 / US 441 to just north of the Osceola Parkway, approximately 7 miles in length
- New lanes will be express lanes
- Project currently in design
- Construction FY 2024
- Work includes pavement milling and resurfacing, bridge reconstruction and roadside safety enhancements





Florida Turnpike Widening


- Widen the Turnpike (SR 91) from south of Kissimmee Park Road north to US 192
- PD&E study now underway finishing early 2020
- Includes enhanced interchange at US 192, a new interchange north of existing Kissimmee Park Road partial interchange, new limited access toll lanes, and modifications to existing partial interchanges
- Includes new and/or widened bridge structures
- Design in FY2020
- ROW FY2020
- Construction FY2024





Marigold Avenue Improvements

- FDOT Safety Study recommends roundabouts for potential safety improvements on Marigold Avenue at Peabody Road, Laurel Avenue, and San Lorenzo Road and a northbound left-turn bay at San Miguel Road
- Potential design and construction funded by FDOT





Buenaventura Boulevard

Safety Improvements


- FDOT study to recommend safety improvements on Buenaventura Boulevard between Florida Parkway and Osceola Parkway
- o Recommendations pending
- o Funded by FDOT





Storey Creek Boulevard

- Connector framework roadway constructed by developers to provide a connection between Pleasant Hill Road and Reaves Road.
- Reaves Road side has started, and the County is coordinating with the developer on a timeline for the portion at Pleasant Hill Road to complete the connection.
