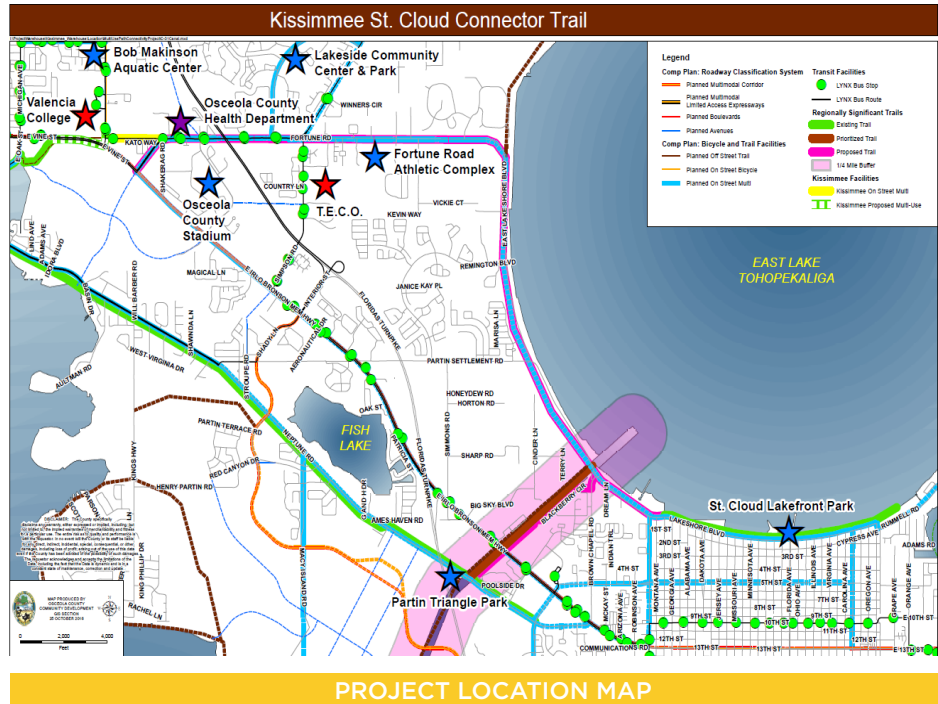

PROJECT DETAILS

Join us online as we unveil the progress we've made on the 1.5-mile long recreational trail connecting Kissimmee and St. Cloud. Input received at our first Public Meeting has been incorporated into the alignment which begins at the existing path on the north side of Neptune Road at Partin Triangle Park, proceeds east along the south side of the C-31 Canal, turns east along public right-of-way over to the east side of Brown Chapel Road and connects to a future trail planned along Lakeshore Boulevard. This federally funded project includes a minimum 8-foot wide shared use path, a signalized pedestrian crossing at Lakeshore, trail signage and minor drainage improvements. The path beneath the US 192 bridge will be located on the berm, will maintain an 8-foot vertical clearance and will be lighted. All pedestrian facilities will be fully compliant with the Americans with Disabilities Act (ADA).

This project is funded for design and construction with a Local Agency Program grant administered by FDOT on behalf of FHWA.

Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability, or family status.
