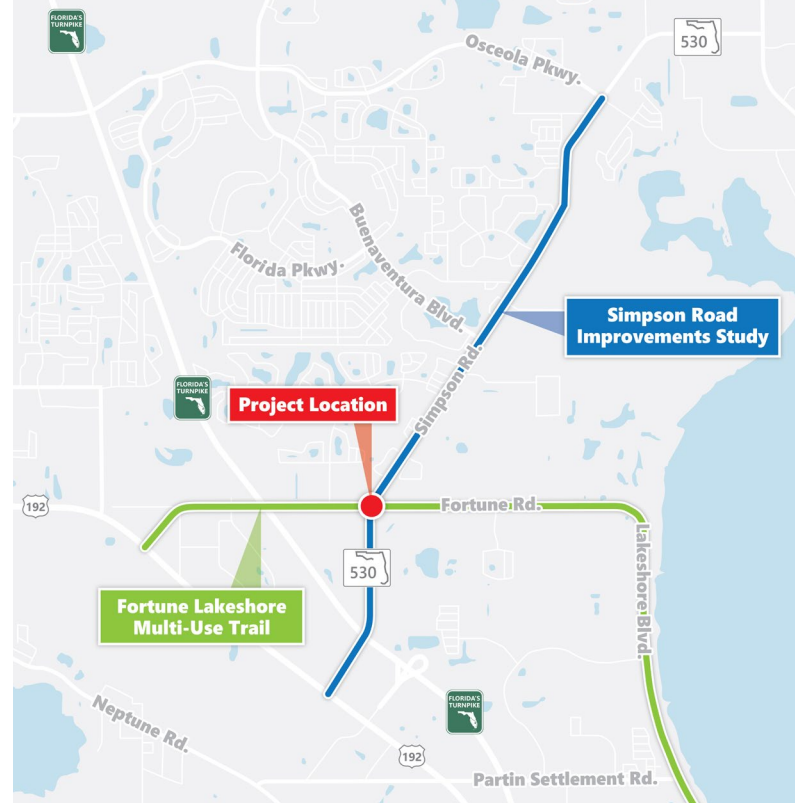

## INTERSECTION IMPROVEMENTS

Osceola County is currently in the design phase for improvements to the intersection of Fortune Road and Simpson Road. This project will improve safety and traffic flow through the intersection and is designed to be consistent with the Simpson Road Project Development & Environment (PD&E) Study and the Fortune Lakeshore Multi-Use Trail project currently in design. The project includes roadway widening to accommodate raised medians, additional turn lanes, bike lanes and a 6-foot to 10-foot wide pedestrian path. Drainage modifications include the addition of curb and gutter and a dry pond on the northwest corner of the intersection. All improvements are designed to meet current Americans with Disabilities Act (ADA) standards.

This project is funded for design and construction with a Local Agency Program grant administered by the Florida Department of Transportation on behalf of the Federal Highway Administration. Right of way acquisition is locally funded by Osceola County.

Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability, or family status. Persons who require special accommodations under the Americans with Disabilities Act (ADA) or persons who require translation services free of charge can contact Mr. Conroy Jacobs, contact information at right, at least seven (7) days prior to the Public Meeting.

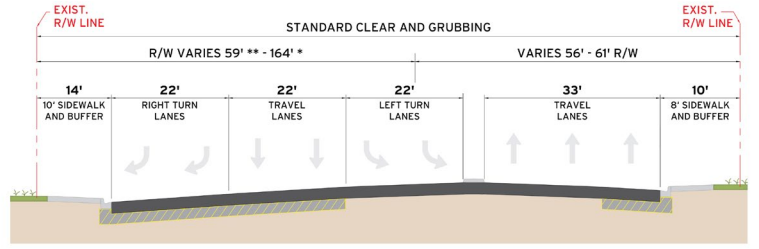

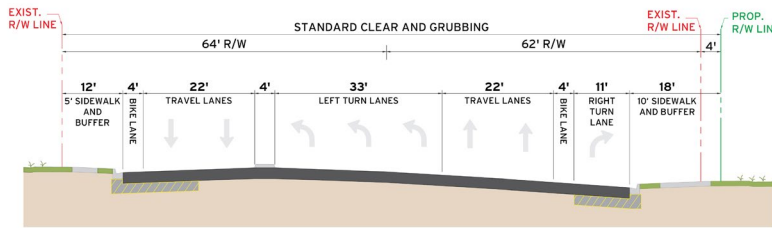

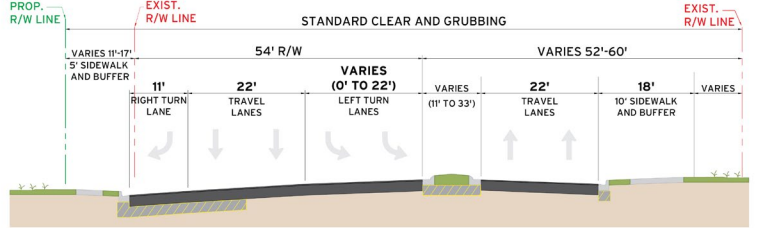
TYPICAL SECTION | SIMPSON ROAD
