You are invited to attend and participate in the Osceola County Department of Transportation and Transit Public Meeting for the design of improvements to the Simpson Road from SR 500 (US 192) to Myers Road. This project is in the design phase and consistent with the recommendations resulting from the Simpson Road Project Development & Environment (PD&E) Study.

Osceola County is offering multiple ways for the community to participate in the public meeting. All participants, regardless of platform they choose, will receive the same information and have access to the same live question and answer.

If you wish to participate in the public meeting from computer, tablet or mobile device, the Virtual Public Meeting will begin at 6 p.m. on Tuesday, March 2, 2021 and will include the same presentation offered at the in-person location. Attendees in the virtual meeting will have an opportunity to download project displays and provide comments or ask questions. If you wish to participate in person, the meeting will


be held on Tuesday, March 2, 2021 in the St. Cloud Meeting Room at Osceola Heritage Park at 1875 Silver Spur Lane, Kissimmee, FL 34744. Attendees will have an opportunity to come anytime between 6 p.m. and 7:30 p.m. to view a looping presentation and project displays, speak with project team members and provide comments. The County requests advance registration for this option by contacting the

project manager using the contact information below to ensure all attendees are accommodated safely and according to social distancing guidelines. ABOUT THE PROJECT

Osceola County is currently in the design phase for Phases 2, 3, and 4 of the Simpson Road Improvements Project. The need for the project is based on capacity and safety, as well as improving connections to the City of Kissimee, Orlando International Airport (OIA), and the emerging NeoCity and Medical City technology clusters. The improvements, as determined by the Project Development and Environment Study (PD&E), include reconstructing Simpson Road from 2-lanes to a divided 4-lane roadway including a 26foot median, a 10-foot shared use path for bicycles and pedestrians on each side of the roadway, street lighting, upgraded signalized intersections, seven stormwater ponds, and areas preserved for landscaping.
