- All food operations occurring at a special event will require a food vending permit from the Health Department according to Chapter 64E-11 of the Florida Administrative Code. Please contact the Health Department at 407-742-8606 for additional information.
- If event activity is to occur in streets, roads, or rights-of-way, applicant shall demonstrate compliance with Sections 336.048 and 316.2045, Florida Statutes.
- Business Tax Receipt under special provisions for vendors with regards to special events is required please contact the Tax Collector's Office to obtain these licenses (407)742-4000.
- If temporary tent(s) and/or temporary sign(s) will be used in conjunction with this event, separate permit applications must be submitted to the Zoning Office with this Special Event application.
- If the Special Event Review Staff determines a Temporary Noise Permit is required, such permit must be obtained by the applicant and approved by the Zoning Staff prior to approval of the Special Event Permit.

Article 3.8 Commercial Uses Siting Standards

3.8.1 COMMERCIAL USES

O. Special Event

Private residences are exempt from the provisions of this regulation. The following standards shall apply:

- 1. A special event shall be limited to between the hours of 7 a.m. and 9 p.m. Sunday through Thursday, and 7a.m. and 11 p.m. on weekends and holidays, unless otherwise approved by the County Manager prior to the event.
- 2. The amount of noise generated shall be in compliance with the County Noise Ordinance.
- 3. All parking provided shall be on-site, unless the Sheriff's Office determines that public safety concerns are adequately addressed for off-site parking.
- 4. All trash and debris shall be removed when the event is over and/or when the use permit expires and site returned to its pre-existing condition.
- 5. All required electrical permits for event shall be obtained by a licensed electrical contractor.
- 6. A letter of approval for the event shall be obtained from the Fire Marshall and / or the Health Department should portable toilets be used, prior to the event. An on-site fire extinguisher(s) shall be located within seventy-five feet of any portion of the tent facility.
- 7. Written consent from the owner, or authorized agent of the property shall be obtained prior to the issuance of a permit.
- 8. A Special Event Permit shall only be granted if staff finds that the parking generated by the event can be accommodated without undue disruption to or interference with the normal flow of traffic. Utilization of off-duty police, sheriff or Highway Patrol officers to direct traffic may be required. Cost of providing same to be incurred by the operator of the special event. In cases where it is deemed necessary, the County Manager may require the applicant to post a bond to ensure compliance with the conditions of the special event permit.
- 9. In cases where the County Manager deems it necessary, the applicant may be required to provide special event insurance coverage up to a limit of \$5,000,000 per occurrence.
- 10. If the applicant requests the County to provide extraordinary services or equipment or the County Manager otherwise determines that extraordinary services or equipment should be provided to protect the public health or safety, the applicant shall be required to pay to the County a fee sufficient to reimburse the County for the costs of these services.
- 11. Display or Meeting Tent requests shall adhere to the following criteria in addition to the above:
 - a. The use permit may be granted for forty-five (45) days, per lot and may be extended up to ninety (90) days by the County Manager.
 - b. When a display/meeting tent is used in conjunction with a seasonal sales lot, only a seasonal sales lot Permit shall be required (a separate display/meeting tent/special event permit shall not be required).

☐ If any event activity is to occur on County Property, then attach copy of the liability insurance rider or policy that names Osceola County amongst the Insured.
\square Application Fee. (If paying by check or money order please make payable to The Board of County Commissioners.)
\Box If off-duty law enforcement is necessary, then attach verification of an agreement to use off duty law enforcement services.
☐ If port-o-lets will be used, then attach a copy of the approval letter from the County Health Department for utilization of port-o-lets. (You may contact the Health Department at 407- 742-8606.)
☐ If tents are to be placed at the event site, then attach an application for a Tent Permit which shall include a Certificate of Flame Resistance and a detailed site plan indicating distance from all property lines.
☐ If signs are to be placed at the event site, then attach an application for a Sign Permit which shall include detailed site plan indicating distance of signs from all property lines.
☐ If level of noise generated by the event is anticipated to exceed noise levels allowable by the Osceola County Noise Ordinance, then provide an application for a Temporary Noise Permit. (If a Temporary Noise Permit application is not provided with the Special Event request, it may be determined by the County that a Temporary Noise Permit is required, and this may delay the review of your Special Event request.)
☐ If temporary modular buildings or other similar type structures are to be placed at the event, a building permit may be required from the Osceola County Building Department. Please contact the Building Department at 407-742-0200.
