OSCEOLA COUNTY'S FREE ON-LINE VENDOR REGISTRATION AND SOLICITATION NOTIFICATION SYSTEM.

Osceola County's on-line vendor registration and solicitation notification system is called VendorLink.

VendorLink allows vendors to view and download solicitations at no cost, 24- hours a day, seven days a week, from any computer with internet access.

Vendors must register to access current solicitations on VendorLink. Solicitations are matched with vendors categorized by the specific commodity or service offered, and vendors are notified of upcoming opportunities via email. Alternatively, vendors may request bid documents from Procurement Services.

Solicitations will continue to be published in local newspapers and posted outside of the Procurement Services office in the County Administration Building in downtown Kissimmee.
