Executive Summary

1. Introduction

The 2024-2025 program year Annual Action Plan represents the fifth and final year of the 2020-2025 Consolidated Plan period. Throughout the 2023-2024 program year, the main objective for HUD Program funding was to capitalize on progress made in the previous program years and evaluate currently funded housing, public service and public facilities/infrastructure projects to determine whether or not the allocated funding is being used to generate the desired outcomes originally planned for and whether they are being implemented on a timely basis. During the 2024-2025 program year, the Osceola County HOME Consortium, in partnership with the City of Kissimmee, intends to continue evaluating the efficacy of currently funded projects and amend our funding goals and objectives accordingly, while also introducing new projects, to maximize the use of Federal, State, and Local funding in our communities and finish this five-year consolidated planning period with two objectives in mind: 1) Improve timeliness of project implementation and funding expenditures; and 2) Provide clarity on what our future funding goals and objectives should be for the next five year period.

2. Summarize the objectives and outcomes identified in the Plan

After careful evaluation of previous program year achievements, coupled with feedback received from public meetings conducted during the development phase of the 2024-2025 Annual Action Plan, Osceola County has selected the following proposed goals, objectives and projects to direct HUD funding towards during the next performance period (October 1, 2024 – September 30, 2025).

3. Evaluation of past performance

The 2023-2024 program year was the County's fourth year of the 2020-2025 Five Year Consolidated Plan. The County was allocated \$1,401,751 in CDBG funds. The Osceola County Consortium (Osceola County and the City of Kissimmee) received HOME funds in the amount of \$1,026,928. Osceola County did not receive any Emergency Solutions Grant (ESG) funding in the 2023-2024 program year. The County implemented its 2023 Action Plan projects, narrowing its focus to the following target areas: Poinciana, Buenaventura Lakes, County-wide activities, and the City of Kissimmee. During the implementation of 2023-2024 projects and activities the County hosted a series of Fair Housing outreach activities, including:

• 2/28/2024 – Fair Housing Table at the Robert Guevara Community Center: The Housing and Community Services Department staffed a Fair Housing Table aimed at engaging the public by offering essential resources, literature, and giveaways. This initiative was designed to raise awareness about fair housing practices and provide valuable information to community members. Through this outreach effort, the department ensured that individuals had access to pertinent resources and materials, fostering a more informed and empowered community in matters related to housing rights and opportunities.

- 2024 Fair Housing Bus Tour: Osceola County, as the lead agency, partnered with the City of Kissimmee to organize a bus tour showcasing recent Community Development Block Grant (CDBG) projects throughout the County. This tour aimed to provide key stakeholders with a firsthand look at the impact and scope of these initiatives within the community. The tour highlighted successful CDBG-funded projects, demonstrating how public funds were utilized to enhance infrastructure, support affordable housing, and improve community facilities. In efforts of spreading fair housing awareness, a video was presented, valuable information including literature was disseminated, and activities were conducted. By engaging stakeholders directly through this tour, Osceola County and the City of Kissimmee effectively illustrated their commitment to improving and building a more sustainable community.
- 2024 Fair Housing PSA Osceola Count collaborated with the City of Kissimmee in the
 filming of a short PSA in video form. The video shows a brief message on the history of
 Fair Housing. See attached. This video was displayed multiple times at multiple
 locations/events including a County Board of County Commissioners Meeting where the
 Fair Housing Proclamation was announced.
- 2024 Fair Housing Lobby Presentation: In the main lobby of the Housing and Community Services building, a presentation was set up for the public. The setup featured a display including a table with banners, informative literature, and giveaways. This initiative was placed to engage clients upon entry, aiming to heighten awareness and understanding of fair housing principles. Overall, the clients found the setup to be informative and valuable.

Via its 2023-2024 Annual Action Plan, the County established its overall goals and objectives to address with HUD Program funding:

The County initially renewed its support to provide healthcare services to very low- and low-income residents through the Buenaventura Lakes Health Clinic. However, no contract renewal was executed between the County and the healthcare provider to continue providing these services during the 2023-2024 program year which led to the cancellation of the project activity. Instead, the County is re-allocating this funding (\$80,000) to support homeless outreach services to be provided by a local designated agency through a Multi-Year Substantial Amendment process.

In regards to affordable housing projects, the County remained focused on the major issue of keeping renters stably housed through providing emergency rental subsidies to low-income residents at-risk of eviction and potential homelessness. Since this program started, the County has provided over \$500,000 in rental subsidies to 61 applicants using program years 2020 – 2023 CDBG public services funding. Eight (8) owner-occupied households received rehabilitation assistance through the CDBG and/or SHIP programs totaling over \$1 million in the last program year. The rehabilitation of St. Cloud Villas II from previous program year funding is still underway by the Osceola Council on Aging (CHDO). Therefore, the 2023-2024 HOME Program funding allocated to the CHDO set-aside projects for Osceola County have not been advertised or encumbered to date. In addition, no potential projects have were identified by the City of Kissimmee during the 2023-2024. Therefore, the CHDO set-side project funding will carry-over for future major affordable housing projects. In an effort maximize the funding available for new construction of rental housing, the County is in discussions with local affordable housing developers and organizations to identify feasible multi-family rental projects to address the increasing rental market prices that continue to burden low- to moderate-income households. The Tenant-Based Rental Assistance Program funded through the HOME Program is still in the design phase.

During the 2023-2024 program year, the design phase of the Deerwood Phase I Sidewalk Improvements Project was completed, and a Contractor was selected to begin Phase II construction in the Summer of 2024. The goal of these sidewalk projects is to provide safe route access for students, parents and faculty traveling on foot or by bike separate from motor vehicles and other road hazards. In an effort to meet timeliness goals, CDBG funding originally allocated to Multi-Family Rental Rehabilitation has been re-allocated to the Royal Palm Culvert Project located in one of our of targeted areas (Buenaventura Lakes). During recent years, this area has experienced significant flooding due to hurricanes that have swept the Central Florida Area. Many low to moderate income households have experienced displacement due to flooding. The project will improve the Outfall drainage system to reduce the number of homes impacted by natural disasters.

4. Summary of Citizen Participation Process and consultation process

In an effort to solicit public input on the goals, objectives and projects that will be included in the 2024-2025 Annual Action Plan, Osceola County conducted two (2) in-person public meetings and one (1) virtual meeting via Zoom. The first in-person public meeting was held at the Robert Guevara Community Center (BVL) on Tuesday, June 25, 2024 at 10 a.m. There were seven (7) attendees at this meeting and no comments were received. The second in-person public meeting was held at the Osceola County Housing and Community Services Department (Marydia/Tropical Park) on Thursday, June 27, 2024 at 10 a.m. There were thirty-three (33) attendees and twelve (12) comments received. A virtual meeting was held via Zoom on Tuesday, June 25, 2024 at 6:00 p.m. There were no attendees and no comments were received. A public hearing was held during the regularly scheduled Citizen's Advisory Task Force Meeting on Thursday, June 27, 2024 at 10 a.m. There was one (1) attendee and no comments were received.

There is a final public hearing scheduled to take place at the regularly scheduled BOCC meeting on August 5, 2024 to present the 2024-2025 Annual Action Plan to the Osceola County Board of County Commissioners and general public to provide any additional input or suggested edits on the Draft for Public Comment version of the Plan and to seek approval to submit the final 2024-2025 Annual Action Plan to HUD prior to the national deadline of August 15, 2024. A public notice regarding the public hearing will be posted in the Osceola Gazette and the County's website at least five (5) days before the scheduled public hearing.

Osceola County will conduct a 30-day public comment period July 11, 2024 – August 12, 2024. Notice of this 30-day public comment period will be advertised in the Osceola News Gazette beginning July 11, 2024 and on the County's website for the entirety of the public comment period.

In order to increase cooperation and coordination efforts between Osceola County and local governmental and non-profit agencies throughout the Central Florida region, the Osceola County Housing and Community Services Department developed a list of eighteen (18) stakeholders composed of local governments, public institutions, and local non-profit housing and supportive service providers that are directly consulted with to discuss potential goals, objectives, projects and activities for the upcoming program year funding, and also ways to increase efficiency in the delivery of services and benefit to the most vulnerable populations in Osceola County. We added an additional five (5) stakeholders for consultation purposes in the last year.

Housing and Community Services works directly with local public and private housing supportive and public service providers by providing annual CDBG funding towards activities such as affordable housing, rental assistance, and other public services activities to expand outreach and coordination to serve low- to moderate-income persons and families, homeless persons and non-homeless, special needs populations.

Housing and Community Services works directly with the Homeless Services Network of Central Florida, who is the lead administrator for the regional Continuum of Care (CoC), through telephone and e-mail to gather the latest Point-in-Time Counts and other vital information necessary to properly document the needs of the homeless population, as well as the inventory of housing and supportive services available to meet the needs of the homeless population.

Osceola County uses ESG funds, when available, towards the expansion of homeless prevention activities since the County does not manage homeless services directly within the local government.

During the 2024-2025 program year, Osceola County anticipates allocating approximately 31% of the annual CDBG allocation to a specific geographical targets area (Buenaventura Lakes) and the remaining 69% will be allocated to countywide activities. Approximately 35% of the annual HOME Program allocation will be allocated to City of Kissimmee, and 65% will be allocated to countywide activities. In terms of overall funding between CDBG and HOME Programs, the County will allocate approximately 32% to specific identified geographic areas and 68% to county-wide activities. Other Federal and State funding will be used to leverage the county-wide activities selected for funding during this program year.

Rationale for the priorities for allocating investments geographically

The projects selected for the 2024-2025 program year underwent consideration based on the level of urgent need, funding availability, and project readiness. Both of the areas the County selected to receive funding have a low- to moderate-income populations of over 55 percent. The remaining portion of the annual CDBG and HOME funds will be allocated to county-wide activities, and residents within all unincorporated areas and Kissimmee, will be eligible to apply for assistance.

Affordable Housing

Introduction

During the program year 2024-2025, Osceola County will be allocating approximately \$4.2 million in Federal and State funding resources towards affordable housing activities. Eligible activities include homeless prevention, new construction-rental, and rental (multi-family) rehabilitation. Eligible recipients must provide proof that their annual gross income is less than 80% of the area median income. All construction or rehabilitation activities will be conducted by County approved developers and contractors, in compliance with City, State and Federal policies and procedures. In some cases, the Osceola County will work in partnership with local housing and supportive service providers and Community Housing Development Organizations to administer Federal and State funded program resources.

AP-60 Public Housing - 91.420, 91.220(h)

Introduction

Osceola County does not own or operate public housing units, and there is no Public Housing Authority in Osceola County. However, the County does administer a Housing Choice Voucher Program (Formerly Section 8). The Housing and Community Services Department, manages a total of 1,941 housing choice vouchers county-wide. This total number includes 212 Osceola County (703 and 704), 40 Mainstream, 38 Veterans Affairs Supporting Housing (VASH), 52 Emergency Housing, and 1,605 Portability vouchers.

Actions planned during the next year to address the needs to public housing

AP-65 Homeless and Other Special Needs Activities - 91.420, 91.220(i)

Osceola County relies on its local housing and supportive service provider partners and the Homeless Services Network of Central Florida (CoC) to provide identification, outreach and beneficiary selection services for public services funded with annual Federal and State funding resources for homeless and non-homeless special needs populations. Their established existence in the community and resources has proven beneficial in delivering the necessary services to persons and families in need of assistance. During program year 2024-2025, approximately \$226,005.75 in CDBG public services funding will used to benefit an estimated 30 persons or households, and \$310,556.36 in HOME funds will be used towards affordable housing activities, including those from the homeless or non-homeless special needs populations.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Due to the County's limited funding and outreach resources for directly addressing homelessness, Osceola County relies on its partnerships with the regional Continuum of Care (CoC) Homeless Services Network of Central Florida, and other local homeless services providers to conduct the necessary outreach and assessment to determine the individual needs of homeless persons and families. Osceola County is committed to ensuring that the at-risk and currently homeless populations are connected with available services through public education awareness and other resources available at the county-level. The County anticipates to assistance at least 35 homeless or at-risk of homelessness persons and families over the next one year period.

Addressing the emergency shelter and transitional housing needs of homeless persons

Although Osceola County does not directly provide emergency shelter and transitional housing for homeless persons, the County does work with local housing and supportive service providers such as The Hope Partnership, Helping Other Make the Effort, and Help Now of Osceola to connect persons in need of emergency shelter or transitional housing. The County anticipates to continue allocating housing and community development funding to these organizations in an effort to expand their ability to assist persons and families in need of these types of services.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to

permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

In addition to working with local homeless services providers, Osceola County allocates housing and community development funding towards affordable housing activities and rental assistance in order to prevent individuals and families from becoming homeless again due to lack of access to affordable rental housing or eviction.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

Osceola County allocates a portion of its annual Federal funding towards affordable housing activities, such as rental assistance and rapid re-housing to assist low-income and extremely low-income families who are at-risk of becoming homeless or become homeless again due to job loss or other local economic factors. The Osceola County also works with homeless or at-risk of homelessness individuals and families to connect them with local public and private agencies that provide other non-housing supportive services such as job training and employment services, counseling, and case management services.

AP-75 Barriers to Affordable Housing -91.420, 91.220(j)

Introduction

In Section MA-40 Barriers to Affordable Housing of the Housing Market Analysis of the 2020-2025 Consolidated Plan, it was concluded that there are two potential public barriers that could have a negative impact on affordable housing development:

Impediment #1: State building codes that require the use of more expensive materials to protect housing structures from natural disasters

Impediment #2: Local mobility and impact fees that could hinder affordable housing development in certain districts and areas within the county.

In addition to public sector barriers, the 2020-2025 *Analysis of Impediments to Fair Housing Choice Plan (AI)* describes how private sector barriers negatively affect fair housing choice, as well as furthering affordable housing activities. The AI Plan identified six (6) potential private sector barriers to affordable housing:

Impediment #1: Discrimination in Housing Sales and Rental

Impediment #2: Lack of Existing/Available Housing Stock and the Geographic Distribution of Affordable Housing Stock

Impediment #3: Community Resistance to development of multi-family rental housing and housing for lower-income or minority households

Impediment #4: Inadequate access for minority households to housing outside of areas minority concentration

Impediment #5: Inadequate access to employment opportunities, transportation and public and social services infrastructure to support increased housing opportunities for lower income, minority, and disabled households

Impediment #6: High loan denial rates and issuance of predatory-style loans, particularly for selected racial and ethnic minorities

Each program year, the County evaluates these impediments and considers the potential negative effects they have on our targeted beneficiaries when planning affordable housing

projects to make a positive impact on our communities.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The County has continued to implement its Local Housing Assistance Plan (LHAP) as provided for in the SHIP program. Between the County's Consolidated Plan, its Analysis of Impediments to Fair Housing Choice, the SHIP program and the AHAC's Incentive Plan, the County is addressing affordable housing needs.

- The County should explore establishing a Housing Trust Fund that uses part of the County's impact fees solely for the purpose of creating affordable housing in the County. The Fund could be used to offer short-term loans to affordable housing developers to pay the impact fees. The loan would be paid back when an affordable housing unit is sold.
- The County should explore partnering with an outside agency to establish a Community Land Trust within the County. The Land Trust would be operated and maintained by a non-profit agency that acquires and holds land for affordable housing. This Trust would lessen the cost of housing for residents by holding the land and only selling the housing unit.

AP-85 Other Actions - 91.420, 91.220(k)

Introduction

The following is a list of actions that Osceola County plans to implement over the next one-year period to achieve success in addressing the housing and community development needs of low-to moderate-income residents and families.

Actions planned to address obstacles to meeting underserved needs

Osceola County will continue working with internal County Departments, as well as other public and private organizations to expand services and leverage Federal and State funding in order to address the underserved needs of the community. Obstacles that arise over the next one-year period will be addressed in two ways: 1) determine the level of urgent need and propose a solution with available resources in the current funding year; and/or 2) re-prioritize future funding based on the level of urgent need and available resources.

Actions planned to foster and maintain affordable housing

Osceola County will continue efforts of fostering and maintaining existing and new affordable housing by working with local CHDOs and developers to expand and increase affordable housing opportunities. Osceola County anticipates allocating \$3.9 million towards affordable housing opportunities during this one-year period.

Actions planned to reduce lead-based paint hazards

The overall goal of Osceola County Consortium is to reduce or eliminate lead-based paint hazards and prevent childhood lead poisoning. This will be accomplished through a coordinated effort of public and private sectors. The County will follow procedures as specified in applicable regulations. During the execution of its CDBG and HOME activities, the County, the City of Kissimmee and their contractors/representatives will provide all required notifications to owners and occupants and inspect for defective paint surfaces in pre-1978 properties. Any defective paint conditions found will be included in the scope of work and treatment provided to the defective areas. All paint inspections, risk assessments and clearance testing of suspect properties will be performed by licensed testing professionals.

Actions to Address LBP Hazards

• If a lead-based paint inspection for a pre-1979 housing rehabilitation project is determined to have less than one milligram per square centimeter (1mg/cm2), construction can proceed with required disclosure and notice. If a lead-based

- paint inspection for a pre-1979 housing rehabilitation project is determined to have less than one milligram per square centimeter (1mg/cm2), construction can proceed with required disclosure and notice.
- If a lead-based paint inspection for a pre-1979 housing rehabilitation projects proves to be lead positive, contractors will be required to proceed in accordance with HUD established procedures prescribed in 24 CFR part 35 for proper management and treatment.
- In addition, Osceola County is in the developing stages of creating an internal policy and
 procedure addressing the identification and abatement of lead based paint hazards. The
 County provides the HUD required informational pamphlets to homeowners and
 contractors to ensure that both the lead safe work and the EPA's Renovation Repair, and
 Painting Rule (RRP) practices are being used for all Federally funded housing activities.

Actions planned to reduce the number of poverty-level families

Osceola County is always planning opportunities that will increase the number of high paying jobs that in-turn increase personal wealth and inspire new economic opportunities to build a better business climate. Osceola County allocates annual funding toward CDBG program projects and activities that specifically target extremely low, very low- and low-income residents and provide job training and employment services in an effort to address impoverished persons and families. In accordance with actions in the 2017-2022 Community Economic Development Strategy, Osceola County will promote the following to assist in reducing the number of families living in poverty:

- 1. Support educational partnerships and activities that encourage learning opportunities;
- 2. Promote programs and activities that prepare the workforce for lifelong learning and everychanging careers;
- 3. Increase educational attainments for the ECF workforce; and
- 4. Attract and retain young talented workers.

Actions planned to develop institutional structure

Osceola County currently works in partnership with nine local non-profit service providers and government agencies in order to deliver services to those in need of services. The County will continue to monitor the strengths and gaps in the current institutional delivery structure over the next one year period, and make necessary adjustments to maximize outcomes using Federal

and State funding. Some potential actions would be to increase internal staff capacity and expanding our consultation list by inviting new or existing local housing and public service providers to become active participants in spreading education regarding the availability of services.

Actions planned to enhance coordination between public and private housing and social service agencies

Each year, Osceola County develops a list of stakeholders and service providers for consultation and service delivery purposes. In order to increase coordination, the County will work with the stakeholders and service providers to collect current and accurate data to make adjustments on the needs of their clientele and measure performance efficiency.

Discussion

In addition, the County is in the process of working with a consultant to update any internal, written policies and procedures regarding monitoring for both County employees and sub-recipients that provide clear and concise monitoring of daily program operations for both performance and long term compliance with requirements of the CDBG and HOME programs, including minority business outreach and comprehensive planning requirements.

Throughout recent years and community polling, the County has determined that its seniors makeup one of the most vulnerable populations in its jurisdiction. We are finding a housing crisis surrounding seniors on fixed income with limited resources including affordable housing opportunities. There has been a notable increase in the number of seniors seeking employment to financially sustain and remain independent. In efforts of providing some relief, the County is working on the launch of a TBRA activity using HOME funds.

6. The County recognizes that elder individuals with low- to very-low income are in need of housing assistance. To address the gap, the elderly population will become the County's targeted pool of applicants for the TBRA Program. The goal of the program is to offer a fixed rental subsidy to approximately 25 senior households on a 12-month rotational basis.
