Once the request is completed, the owner, or that individual who is at least 18 years of age and is authorized to act on behalf of the owner, must return the original form in person to the Code Enforcement Board Administrative Secretary, Code Enforcement Department, 1 Courthouse Square Ste. 1100, Kissimmee, Florida 34741. The request must be either notarized upon execution or executed before a Notary in the Code Enforcement Department. If you choose to execute the request before a Notary in the Code Enforcement Department, you must present a picture ID. Upon receipt, your request will be placed on the next available Board of County Commissioners agenda as set forth below. If you have any questions please call the Administrative Secretary at (407) 742-0400. The Board of County Commissioners will consider requests for reduction of penalty only one time for each individual case. If you fail to appear at the hearing date, as set forth below, without submitting a written request to have same continues, you may be forfeiting your right to be heard in this matter. The Board's decision is final.

If you choose to have someone represent you other than an attorney, you must provide a letter of authorization which contains the name of the individual who will be representing your interest. Additionally, in order for the Board of County Commissioners to consider the testimony of the individual, the letter must be signed by you and notarized.
