1 Individuals 55 years of age or older shall receive a 50% discount on County tag fees. \$2.00 of fee collected may be retained by veterinarians who issue County license tags to cover administrative expenses.

2 The County Manager or designee may waive or reduce fees for events or during times of heavy animal intake. Animal Rescue organizations with an approved rescue agreement shall pay the adoption fee designated in the agreement, unless at the time of rescue there are lower fees offered in accordance with the County’s Adoption Marketing Strategies.

3 In criminal cases mileage will be charged as applicable based on Internal Revenue Service 41 CFR Part 301-10, or as published in IRS Revenue Procedures or News Releases or the US General Services Administration (GSA) website.

4 Daily board fee for livestock will include the base fee of \$25 per animal, plus any applicable medical fees.
