

## **Dillingham Apartments**

A complex considered a first of its kind here in Osceola County, Dillingham Apartments is partly the result of a funding effort between the Osceola County BOCC and the City of Kissimmee. In collaboration with Park Place Behavioral Health Care, the complex will provide low-income residents of Osceola County with special needs earning 22-60% of the area median income (AMI) with access to supportive services. These services include mental health care, case management, peer specialists, agency resources, and support in accessing social services available within the community. The three-story building will feature 30 apartment units, as well as a combined entertainment room, community room, computer room, and classroom. The grand opening and ribbon cutting occurred on June 5, 2024.





## **Cameron Preserve Phase II**

The Osceola County BOCC celebrated the opening of 84 new affordable rental housing units at Cameron Preserve Phase II on August 28, 2024. Cameron Preserve Phase II is an affordable housing community for low-income families and individuals earning at or below 60% of the area median income (AMI). Phase II shares recreational facilities with Phase I, which includes 100 affordable rental housing units and amenities such as a community pool, gym, and a building with classroom space. Resident programs such as employment assistance, health and wellness services, financial management programs, and an on-site food pantry are available. Phase II included an \$8.2 million financial commitment from the Osceola County BOCC and a partnership with Florida Housing Finance Corporation. The units will remain affordable for 50 years.





# Community Resources Network Events By Arleen Fernandez



Throughout this past year, Osceola County Housing and Community Services has proudly led the organization of Community Resources Network Events across every district in Osceola County. These events have been pivotal in connecting residents with vital information, assistance, and resources aimed at addressing a wide range of community needs. With strong support from the Osceola County BOCC and the active participation of over 40 key partner agencies including the Osceola Library System, Florida Department of Health, Community Legal Services, Department of Veterans Affairs, and Florida Department of Agriculture. These events have served as a crucial platform for delivering up-to-date services and information to those in need.

Each event was tailored to ensure residents received timely access to resources such as healthcare, legal assistance, veterans' services, and agricultural support, among others. By working collaboratively with our partner agencies, we were able to ensure that all residents, regardless of their specific needs, were delivered up-to-date information and access to services. The success of these events speaks to the dedication and coordinated efforts of all involved.

## **ELDERLY SERVICES** By Wilda Belisle

The County is dedicated to supporting the needs of older adults in our community. Our office, with the help of knowledgeable coordinators, provide information and referrals to various support services tailored for seniors.

In addition to referrals, the office offers several specialized programs designed to promote health, wellness and social engagement for seniors aged 55 and older.

**Zumba Classes:** Available at the Robert Guevara Community Center. These classes provide a fun and safe way for seniors to stay active and improve their fitness through dance and aerobic exercise.

**Senior Smile Program:** Recognizing the importance of oral health, this program serves seniors aged 55 and older who need dentures or partials. It includes the initial dental examination and the provision of necessary dentures.

**Eyeglass Program:** This program addresses vision care for seniors who lack insurace coverage for eyeglasses. It covers the cost of eye exams and eyeglasses, ensuring that seniors have access to necessary vision care.

## **Our Community**

Yadira Gonzalez, single mom of two, was a returning applicant from the prior year. Ms. Gonzalez was unable to secure a home the first time she applied. Rather than giving up, she used this setback as motivation to change her strategy. Ms. Gonzalez started saving money monthly in preparation of becoming a homeowner one day. She treated her personal savings account as a "bank", to mimic what it would be like to be a homeowner one day. When the purchase assistance program reopened in spring of 2024, Yadira re-applied. Yadira was able to secure a single-family home where she could continue to raise her boys. Yadira's journey is a powerful testament to resilience and hope. Her story is proof that dreams of homeownership are within reach, and we were thrilled to see it unfold before our eyes!

When Ms. Cain first applied for the Owner-Occupied Rehabilitation program, her hope was to make her home more accessible for her husband. As an elderly couple who had weathered many life challenges together, the upgrades represented ongoing independence. During the preliminary phase of the project, her husband passed away leaving Ms. Cain alone in the home. Ms. Cain later shared with staff that the OOR project gave her something to look forward to although her husband would never be able to benefit from the upgrades. The addition of the new appliances and the refurbished front porch brought life to Ms. Cain. Since her husband's passing, she as been able to spend most of her day outside on her rocking chair. Ms. Cain continues to show her appreciation of the program, in attending our CDBG Community Meetings and giving her testimony to others.
